ICAR - National Institute of Biotic Stress Management (ICAR-NIBSM), located in Baronda, Raipur, Chhattisgarh, is inviting applications from eligible candidates for the position of **One Field Assistant (FA)** in an ICAR-FFP funded project titled "*Socio economic upliftment of tribal farmers through suitable agricultural enterprises integration in rice fallow pulse cropping system A participatory approach for doubling the farmer's income.*" This is a purely contractual position. Interested candidates who meet the eligibility criteria can attend the Walk-in-interview and required to bring a duly filled application in the prescribed format (refer to Annexure - I) to the Walk-in-Interview. Terms and Conditions:

1. The engagement for this position is temporary, non-regular, and based on a co-terminus basis. The services of the appointed individual will be terminated upon the expiry of the specified period mentioned in the approval, or earlier if their performance is deemed unsatisfactory.
2. The age limit for candidates will be determined based on their age at the time of the walk-in-interview.
3. The period of engagement for the Field Assistant (FA) up to 31.03.2024 or until the project's approval/extension date, whichever comes first. The continuation or extension of the position beyond the initial one year will be subject to the instructions and orders of ICAR-FPP.
4. There is no provision for re-engagement after the termination of the project, scheme, or plan. The selected candidate does not have any legal right to claim regularization, absorption into a permanent position, or any further engagement after the contract's termination at ICAR-NIBSM.
5. The government aims to achieve a balanced workforce and encourages women candidates to apply.
6. The appointments may be terminated at any time without prior notice or without providing a reason.
7. The assigned place of work will be at Farmer Communication Center, Asnid Panchayat, Kasdol Block, Baloda Bazar District, Chhattisgarh. The position may require working or traveling to selected locations within Chhattisgarh for project-related activities.
8. No travel allowance (TA) or daily allowance (DA) will be provided for attending the interview.
9. The selected candidate must obtain a 'No Objection Certificate' from their current employer if they are currently employed elsewhere.
10. The selected candidate will be required to present all original documents and a medical certificate at the time of joining.
11. Candidates intending to participate in the interview must declare in writing in advance if they have any relatives, whether close or distant, who are employed by ICAR/NIBSM. They must provide details such as the relative's name, designation, nature of duties, and their relationship.
12. Concealing facts or engaging in any form of canvassing will result in disqualification or termination. If any candidate is found to have submitted false claims at a later stage, their candidacy will be summarily rejected.
13. All recruitment guidelines will be followed in accordance with the ICAR guidelines.
14. Emoluments will be fixed based on the ICAR guidelines, subject to any revisions made from time to time.
